# **Question 13**

Madam Speaker, could the Premier and Minister of Finance please tell this Honourable House how many government employees will be eligible for retirement at 25 years and 33 1/3 years respectively within the next 5 years and 10 years' marks? Could he also advise on the pension costs to government at the two intervals and what plans the government, with the requisite timelines for each to address the growing pensions cost on the government?

# **Question 14**

Madam Speaker, could the Premier and Minister of Finance please advise this Honourable House of the current situation with the Ellis Thomas Downs and when was the last time that he met with the landowners to resolve the present dispute? Could he also advise when the people of the Territory could expect to see horse racing back at that location?

# **Question 15**

Madam Speaker, U.S. Health Officials have recommended to the U.S. Drug Enforcement Administration that marijuana be classified as a lower-risk drug (removing it from Schedule one to a Schedule three drug), could the Premier and Minister of Finance advise if his government has any plans to decriminalize the use of small quantities of marijuana for recreational use with the appropriate safeguards in place?
